Applications Within Food/Feed Plants - Non-Food/Feed Areas: Deltadust is a ready-to-use insecticide dust which has given effective knockdown and residual control of the pests listed. Applications are permitted in the non-food/feed areas of food/feed handling and processing establishments as a spot or crack and crevice treatment.

If removal is not feasible, retreat the nest, if necessary. Do not use this product to treat overhead nests.

WEBBING CLOTHES MOTHS: Use Deltadust as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on the clothes. DO NOT apply this product directly to clothing.
